BAC RESOLUTION AWARDING THE PROCUREMENT OF FOOD ASSISTANCE & OTHER RELIEF GOODS FOR THE AFFECTED HOUSEHOLDS (LIVE CHICKEN)

WHEREAS, per resolution of BAC dated May 28, 2020, Rule XVI of Section 48 of the Implementing Rules and Regulations (IRR) provides for an alternative Mode of procurement:

WHEREAS, the Negotiated Procurement (Emergency Cases) under Sec 53(b) of Republic Act (RA) No.9184 and Section 53.2 of its 2016 revised Implementing Rules and Regulations (IRR), the Government Procurement Policy Board-Technical Support Office (GPPB-TSO) is issuing this opinion to guide all Procuring Entity (PEs) in the conduct of their Procurement Projects under this modality;

WHEREAS, one of the alternative modes of procurement is Negotiated Procurement (Emergency Cases), wherein the procurement of Goods, Infrastructure Projects and Consulting services in case of imminent danger to life or property during a state of calamity;

WHEREAS, the procurement of food assistance and other relief goods for the affected households (live chicken) in the amount of *Nine Hundred Ninety Five Thousand Eight Hundred Sixty Five Pesos and Twenty Centavos* is an unforeseen event and thus, the procurement entity resorted to the alternative mode of procurement:

WHEREAS, pursuant to the said provision, the procuring entity request the submission of price quotation from the supplier of known qualifications, namely *Reign Farm, San Miguel Foods Inc., Bounty Agro Ventures, Inc.*;

WHEREAS, from the quotations submitted by the three (3) establishments, the quotation of *Reign Farm* to procure of food assistance and other relief goods for the affected households (live chicken) in the amount of *Nine Hundred Ninety Five Thousand Eight Hundred Sixty Five Pesos and Twenty Centavos (Php 995,865.20)* is the Lowest Calculated & Responsive Bid;

NOW, THEREFORE, the BIDS AND AWARDS COMMITTEE (BAC) hereby recommends that the quotation submitted by quotations submitted by the three (3) establishments, the quotation of *Reign Farm* be approved pursuant to Section 53.2 of IRR of RA 9184, being the more advantageous terms to the government.




